**ORDER EXEMPTING CHAPTER 7, CHAPTER 13, CHAPTER 11, AND SUBCHAPTER
V TRUSTEES FROM FEES FOR ELECTRONIC ACCESS TO COURT DATA**

On June 11, 2021, this Court entered its *Order Exempting Chapter 7, Chapter 13, Chapter 11, and Subchapter V Trustees from Fees for Electronic Access to Court Data* (the “**Prior Order**”), bearing docket number Miscellaneous No. M-02-20004. Under the Prior Order the Court had exempted certain Chapter 7, Chapter 13, Chapter 11, and Subchapter V trustees (the “**Trustees**”) from electronic access fees incurred in the course of their duties. Since entry of the Prior Order, the Court’s panel of Trustee has changed, and the Court finds that cause exists to modify the Prior Order as set forth herein.

The Court finds that bankruptcy case trustees practicing before this Court fall within a class of persons that the Court may exempt from payment of electronic access fees as prescribed by the Judicial Conference. The Court finds that an exemption for the trustees and their staff is necessary to avoid unreasonable burden and the exemption will promote public access to information. Accordingly, the following trustees and their staff shall be exempt from the payment of fees for access via PACER to the electronic case files maintained by the Clerk of Court, providing such use is incurred in the course of their duties as trustees: *See Exhibit A attached hereto.*

This order does not exempt the trustees and their staff from the payment of fees incurred in connection with access to PACER for other purposes. Additionally, trustees and their staff must not sell the data obtained as a result of the fee exemption and must not transfer any data obtained as the result of the fee exemption.

This exemption will be reviewed annually and may be revoked at the discretion of the Court at any time.
