ORDER EXEMPTING CHAPTER 7 AND
CHAPTER 13 TRUSTEES FROM ELECTRONIC PUBLIC
ACCESS FEES INCURRED IN PERFORMING TRUSTEE WORK

Upon consideration of exemption from electronic public access fees for certain persons, and

IT APPEARING that the Judicial Conference, at its March 14, 1995, session approved the addition of an advisory note to the miscellaneous fee schedule promulgated under 28 U.S.C. § 1930, for the purpose of clarifying the judiciary's policy with respect to granting exemptions from electronic public access fees prescribed under those schedules; and

IT FURTHER APPEARING that an exemption from the electronic public access fees for trustees in performing trustee work in cases in which they are appointed under chapters 7 and 13 would improve bankruptcy administration within the district and would encourage use of electronic public access; it is


ORDERED that effective immediately, the bankruptcy trustees in this district are exempt from payment of the electronic public access fees prescribed by 28 U.S.C. § 1930(b) in performing trustee work in connection with cases in which they are appointed under chapters 7 and 13. It is further

ORDERED that each trustee shall make arrangements timely to establish an exempt account for trustee work with the PACER Service Center, shall limit use of that account to trustee work, and, as required, shall make arrangements timely to establish a billable account for non-trustee work. It is further

ORDERED that this order supplants the Order Exempting Cynthia A. Niklas, Chapter 13 Trustee From Bankruptcy Court Miscellaneous Schedule Item (23), etc., entered on May 24, 2001, and bearing the docket number Miscellaneous No. M-01-20001, except that Ms. Niklas's exemption is effective as of June 1, 2001, as under the prior order. It is further

ORDERED that the clerk shall post this order on the court's website and make it available, upon request, for public inspection at the clerk's office.
